GENERAL INFORMATION

1. Each space measures 10' x 10', assignments will be made by the SWT & BMA committee.
2. Vendors must provide all materials for their booth space; including tables, chairs, equipment, tents and signage (shade providing tents or popups are strongly encouraged).
3. No amplified sound is allowed. Power generators must be approved by the SWT & BMA planning committee.
4. Acceptance/Rejection letters will be mailed upon receipt of application. The SWT & BMA planning committee has the right to deny an application if several other applications have already been accepted for the sale of similar goods.
5. No refunds will be made once an application is accepted, for any reason! Rejected applications will receive a full refund.
6. Please note vendor setup may be delayed due to inclement weather conditions. If there is bad weather, you will be notified of any changes upon arrival to the festival grounds, or you may call Gordon West at (505) 975-0414 for updated information.
7. The vendor is responsible for all setup, tear down and cleanup of leased space.
8. Paved and dirt surfaces are available on a first come, first served basis and will be assigned by the SWT & BMA committee.
 - a. Paved surfaces are non-penetrable, therefore only filled bucket tie downs are allowed. Stakes may be used on dirt surfaces though filled bucket tie downs are also recommended.
9. The SWT & BMA and it's members are not liable for loss or theft of any personal property, goods or belongings. Vendors are responsible for maintaining security of their leased space at all times.
10. Vendors may setup between 3:00p - 5:00p on Friday, and 7:00a- 8:30a on Saturday and Sunday.
